

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Choulic Community FY 2016 Budget Amendment No. 3)**

**RESOLUTION NO. 16-233**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation and to appropriate**  
3 **these funds for the benefit of the Nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1 (d) (2)); and**

7 **WHEREAS, the FY 2016 Baboquivari District Budget in the amount of \$2,089,369.21 was**  
8 **approved by Resolution No. 15-374 which was amended by Resolution No. 15-406**  
9 **for Amendment No. 1 and Resolution No. 16-011 for Amendment No. 2 and**  
10 **Resolution No. 16-177 Amendment No. 3 increased overall total budget to**  
11 **\$2,154,346.56; and**

12 **WHEREAS, Choulic Community approved to amend their FY 2016 Budget increasing the**  
13 **following line items 6120 Worker's Comp, 6215 Employer Dental, 7000 Supplies**  
14 **Office, 7100 Utilities, 7400 RM Equipment, and establishing a blanket purchase**  
15 **order with Arizona Office Technologies in the amount of \$500.00, line item 7620**  
16 **Miscellaneous Assistance, and adding language "but not limited to", line item**  
17 **7640 Emergency Assistance; line item 7645 Wake Assistance, decreasing line**  
18 **item 7355 Professional Services; and**

19 **WHEREAS, this amendment No. 3 will not affect Choulic Community's FY 2016 current**  
20 **budget in the amount of \$213,214.75, nor will affect the overall Baboquivari**  
21 **District FY 2016 budget in the amount of \$2,154,346.58; and**

22 **WHEREAS, the Budget and Finance Committee has reviewed Choulic Community FY 2016**  
23 **Budget Amendment No. 3 and recommends its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
25 **Choulic Community FY 2016 Budget Amendment No. 3.**

26 **BE IT FURTHER RESOLVED that amendment No. 3 will not affect Choulic Community's FY 2016**  
27 **current budget in the amount of \$213,214.75 and adding language to Line Item**  
28 **7620, nor will it affect the overall Baboquivari District FY 2016 budget in the**  
29 **amount of \$2,154,346.58.**

30 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
31 **District Chairperson and any designated official to expend and administer the**

budget, provided that any modification or amendments shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0- AGAINST; -0- NOT VOTING; and 219.9 [04] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
