9		for Amendment No. 1 and Resolution No. 16-011 for Amendment No. 2 and
10		Resolution No. 16-177 Amendment No. 3 increased overall total budget to
11		\$2,154,346.58; and
12	WHEREAS,	Tohono O'odham Legislative Council approved FY 2016 Apportionment of
13		Mining Royalties by Equal Distribution by Resolution No. 16-017 which allocated
14		\$115,253.30 to each District; and
15	WHEREAS,	Artesia\Little Tucson Community will be incorporating their portion of FY 2016
16		Mining Royalties in the amount of \$16,464.76, which will increase line item 6005
17		Occasional Appointment, line item 6110 FICA and line item 6120 Workers Comp,
18		increasing existing Operational line item 6500 Training Fees and Registration,
19		line item 6510 Lodging, line item 6520 Per Diem, line item 7010 Program
20		Supplies, line item 7110 Communications, line item 7340 Public Relations, line
21		item 7615 Donations/Contributions, line item 7640 Emergency Assistance, and
22		line item 7645 Wake Assistance; and
23	WHEREAS,	this amendment No. 1 will affect Artesia\Little Tucson Community FY 2016
24		current budget in the amount of \$181,515.65 to a revised amount of \$197,980.41
25		and will affect the overall Baboquivari District FY 2016 budget to a revised
26		budget of \$2,170,811.34; and
27	WHEREAS,	the Budget and Finance Committee has reviewed Artesia\Little Tucson
28		Community FY 2016 Budget Amendment No. 1 and recommends its approval.
