8		approved by Resolution No. 15-374, which was amended by Resolution No. 15-
9		406 for Amendment No. 1 and Resolution No. 16-011 for Amendment No. 2 and
10		Resolution No. 16-177 Amendment No. 3 and Resolution No. 16-234 Amendment
11		No. 1 Artesia\Little Tucson Community budget to a revised total of \$2,170,811.34;

13	WHEREAS,	Tohono O'odham Legislative Council approved FY 2016 Apportionment of
14		Mining Royalties by Equal Distribution by Resolution No. 16-017 which allocated
15	ļ	\$115,253.30 to each District; and
16	WHEREAS,	South Komelic Community will be incorporating their portion of FY 2016 Mining
17		Royalties in the amount of \$16,464.76 which will increase line items 6500
18		Training Fees and Registration, 6510 Lodging, 6520 Per Diem, 6530
19	:	Transportation, 7035 Building Materials; and
20	WHEREAS,	this Amendment No. 1 will affect South Komelic Community's FY 2016 current
21		budget in the amount of \$201,423.45, to a revised amount of \$217,888.21 and will
22		affect the overall Baboquivari District FY 2016 budget to a revised budget of
23		\$2,187,276.10; and
24	WHEREAS,	the Budget and Finance Committee has reviewed South Komelic Community FY
25		2016 Budget Amendment No. 1 and recommends its approval.
