

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Education Administration Budget Amendment No. 1)**

RESOLUTION NO. 16-240

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 Education Administration Budget in the amount of \$487,580.88 was**
8 **approved by Resolution No. 15-165; and**

9 **WHEREAS, the Education Administration has prepared and submitted for review its FY 2016**
10 **Budget Amendment No. 1 which is incorporated by this reference and which (1)**
11 **creates line items 7355 Professional Services and 7430 RM Grounds; (2) allows for**
12 **a decrease of 7410 RM Vehicles; and (3) provides for no change in the base FY 2016**
13 **Budget amount of \$487,580.88; and**

14 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
15 **reviewed the FY 2016 Education Administration Budget Amendment No. 1 and**
16 **recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
18 **approves the FY 2016 Education Administration Budget Amendment No. 1 with no**
19 **change in the base amount of \$487,580.88.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2016 Education Administration Budget as amended, provided**
23 **however, that any amendments or modifications shall be submitted for further**
24 **prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day**
26 **of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and 219.9 [06] ABSENT, pursuant to the powers vested in the Council by Article**
28 **VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
