

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2016 Head Start Grant Administration Budget Amendment No. 1)**

**RESOLUTION NO. 16-241**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2016 Head Start Grant Administration Budget in the amount of \$317,057.00**  
8 **was approved by Resolution No. 15-186; and**

9 **WHEREAS, the Head Start Grant Administration has prepared and submitted for review and**  
10 **approval its FY 2016 Budget Amendment No. 1, which is incorporated by this**  
11 **reference and which (1) increases expenses in 7000 Supplies-Office, and 7100**  
12 **Utilities; and (2) creates new line items 6500 Training Fees and Registration, 6510**  
13 **Lodging, 6520 Per Diem, 6530 Transportation, and 7420 RM Building – all by**  
14 **utilizing salary savings in the amount of \$12,848.10 from two positions: Senior**  
15 **Program Manager and Receptionist; and**

16 **WHEREAS, the FY 2016 Head Start Grant Administration Budget Amendment No. 1 will not**  
17 **change the FY 2016 Head Start Grant Administration Budget amount; and**

18 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
19 **reviewed the FY 2016 Head Start Grant Administration Budget Amendment No. 1**  
20 **and recommend its approval.**


21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
22 **FY 2016 Head Start Grant Administration Budget Amendment No. 1, which**  
23 **provides for no change to the FY 2016 Head Start Grant Administration Budget.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer and**  
26 **expend the FY 2016 Head Start Grant Administration Budget as amended,**  
27 **provided however, that any amendments or modifications shall be submitted for**  
28 **further prior approval by the Tohono O'odham Legislative Council.**


