12		Utilities; and (2) creates new line items 6500 Training Fees and Registration, 6510
13		Lodging, 6520 Per Diem, 6530 Transportation, and 7420 RM Building - all by
14		utilizing salary savings in the amount of \$12,848.10 from two positions: Senior
15		Program Manager and Receptionist; and

17		change the FY 2016 Head Start Grant Administration Budget amount; and
18	WHEREAS,	the Human Resources Development and Budget and Finance Committees have
