

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2016 Gu Achi District's Mining Royalties Budget in the
amount of \$115,253.30)

RESOLUTION NO. 16-243

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized to appropriate "funds for
2 the benefit of the nation and its members," including the Nation's districts,
3 provided that "[n]o district council shall expend district funds except pursuant to
4 budgets authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council." (Constitution of the Tohono O'odham Nation, Article
6 VI, Section 1(d)(2), Article IX, Section 7)); and

7 **WHEREAS,** the Tohono O'odham Legislative Council passed Resolution #16-017 "*Approving*
8 *FY 2016 Apportionment of Mining Royalties by Equal Distribution*" for a
9 distribution formula of \$1,267,786.29 to the eleven political Districts with a
10 distribu tion amount of \$115,253.30 allocated to the Gu Achi District; and

11 **WHEREAS,** the Gu Achi District Council approved a budget in the amount of the \$115,253.30
12 (*Resolution #0516-119*) from the apportionment of the mining royalties for the
13 following budget line item - #7500 Capital Equipment; and

14 **WHEREAS,** the Budget and Finance Committee did review the Gu Achi District's FY2016
15 mining royalties budget and recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED THAT** the Tohono O'odham Legislative Council does hereby
17 approve the Fiscal Year 2016 Gu Achi District's Mining Royalties Budget in the
18 amount of \$115,253.30 as attached hereto.

19 **BE IT FINALLY RESOLVED THAT** that the Tohono O'odham Legislative Council hereby authorizes
20 the Chairperson and any designated official to expend and administer the budget
21 as attached, provided that any amendments affecting the funds or funding levels
22 is submitted for further prior approval by the Tohono O'odham Legislative
23 Council.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day**
25 **of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,801.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and 219.9 [06] ABSENT, pursuant to the powers vested in the Council by Article**
27 **VI, Section 1(d)(2) and Article IX, Section 7 of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**






