

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2016 Department of Health and Human Services, Child Welfare  
Tribal Budget Amendment No. 2)**

**RESOLUTION NO. 16-248**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation...and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2) and (3)); and

7 **WHEREAS,** the FY 2016 Department of Health and Human Services, Child Welfare Tribal  
8 Budget in the amount of \$2,186,903.00 was approved by Resolution No. 15-165,  
9 and Amendment No. 1 to increase funding by \$400,000.00 was approved by  
10 Resolution No. 16-196; and

11 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
12 review and approval its FY 2016 Child Welfare Tribal Budget Amendment No. 2,  
13 which is incorporated by this reference and which (1) increases Personnel  
14 Expense line items in order to fund the salaries of eleven new positions for the  
15 remainder of the current fiscal year; and (2) creates new line items 6020  
16 Overtime Wages, 7310 Employee Security Clearance, and 7500 Major Capital;  
17 and

18 **WHEREAS,** the FY 2016 Department of Health and Human Services, Child Welfare Tribal  
19 Budget Amendment No. 2 will increase the Department of Health and Human  
20 Services, Child Welfare FY 2016 Tribal Budget by \$3,594,507.00 from  
21 \$2,586,903.00 to \$6,181,410.00; and

22 **WHEREAS,** the Health and Human Services and the Budget and Finance Committees have  
23 reviewed the FY 2016 Department of Health and Human Services, Child Welfare  
24 Tribal Budget Amendment No. 2 and recommend its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
26 FY 2016 Department of Health and Human Services, Child Welfare Tribal Budget  
27 Amendment No. 2 which includes a \$3,594,507.00 increase from \$2,586,903.00 to  
28 \$6,181,410.00 that shall be funded by the Nation's general fund.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
30 O'odham Nation Chairperson or any designated official is authorized to  
31 administer and expend the FY 2016 Department of Health and Human Services,  
32 Child Welfare Tribal Budget as amended, provided however, that any

amendments or modifications shall be submitted for prior approval by the  
Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>th</sup> day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
