

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 1 to the Intergovernmental Agreement between the**  
**Arizona Department of Economic Security and the Tohono O'odham Nation)**

**RESOLUTION NO. 16-249**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the authority to "promote, protect and provide for public health, peace,**  
3 **morals, education and general welfare of the Tohono O'odham Nation and its**  
4 **members" and to "consult, negotiate and conclude agreements and contracts on**  
5 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
6 **and other Indian tribes or their departments . . ." (Constitution, Article VI,**  
7 **Section 1(c)(2) and Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Nation provides services to provide employment and**  
9 **training programs operated by the Education Department's One Stop Division**  
10 **through funding provided by the Arizona Department of Economic Security**  
11 **("ADES") Workforce Innovation and Opportunity Act; and**

12 **WHEREAS, on March 30, 2016, the Tohono O'odham Nation entered into a cost-**  
13 **reimbursement Intergovernmental Agreement ("IGA") with ADES for the**  
14 **Workforce Innovation and Opportunity Act pursuant to Resolution No. 15-441,**  
15 **Contract Number DI16-002161; and**

16 **WHEREAS, Amendment No. 1 amends the IGA to provide that for the period of July 1, 2014,**  
17 **though June 30, 2016, the contract reimbursement ceiling is increased from**  
18 **\$322,668.00 to \$612,053.00, an increase of \$289,385.00; and**

19 **WHEREAS, Amendment No. 1 will increase fund balances for the Program Year ("PY") and**  
20 **Fiscal Year ("FY") as follows:**

1 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
2 **reviewed Amendment No. 1 to the IGA between the ADES and the Tohono**  
3 **O'odham Nation for the Workforce Innovation and Opportunity Act and**  
4 **recommend its approval.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
6 **Amendment No. 1 to the IGA between the ADES and the Tohono O'odham Nation**  
7 **for the Workforce Innovation and Opportunity Act, Contract Number DI06-**  
8 **002161 and authorizes the chairperson of the Tohono O'odham Nation to**  
9 **execute it in substantially the form attached hereto.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
11 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0-**  
12 **AGAINST; -0- NOT VOTING; and 180.6 [04] ABSENT, pursuant to the powers vested in the Council**  
13 **by Article VI, Section 1(d)(2), Section 1(c)(2) and Section 1(f) of the Constitution of the Tohono**  
14 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
15 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
16 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


