

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Economic Development Delegation Budget Amendment No. 1)**

RESOLUTION NO. 16-251

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 Economic Development Delegation Budget in the amount of**
8 **\$2,084,220.00 was approved by Resolution No. 15-165; and**

9 **WHEREAS, the Economic Development Delegation has prepared and submitted for review**
10 **and approval its FY 2016 Budget Amendment No. 1, which is incorporated by this**
11 **reference and which increases line item 7340 Public Relations; and**

12 **WHEREAS, the FY 2016 Economic Development Delegation Budget Amendment No. 1 will**
13 **increase the Budget by \$345,018.00 to a new overall budget amount of**
14 **\$2,429,238.00; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2016 Economic**
16 **Development Delegation Budget Amendment No. 1 and recommends its**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
19 **the FY 2016 Economic Development Delegation Budget Amendment No. 1 which**
20 **includes a \$345,018.00 increase from \$2,084,220.00 to \$2,429,238.00 that shall be**
21 **funded by the Nation's general fund surplus.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
23 **O'odham Nation chairperson or any designated official is authorized to**
24 **administer and expend the FY 2016 Economic Development Delegation Budget**
25 **as amended, provided however, that any amendments or modifications shall be**
26 **submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH**
28 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and 180.6 [06] ABSENT, pursuant to the powers vested in the Council**
30 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
31 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**
