

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Hewel Ni'ok Corporation for Public Broadcasting Community
Service Grant Budget Amendment No. 1)

RESOLUTION NO. 16-252

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 Hewel Ni'ok Corporation for Public Broadcasting Community**
8 **Service Grant (CPB CSG) Budget in the amount of \$265,116.81 was approved by**
9 **Resolution No. 15-205; and**

10 **WHEREAS, the Hewel Ni'ok has prepared and submitted for review and approval its FY 2016**
11 **Budget Amendment No. 1 which is incorporated by this reference and which (1)**
12 **freezes the position of Culture Affairs Director; (2) creates a Station Manager**
13 **position; (3) increases Personnel Expense line items; (4) increasing line item**
14 **7355 Professional Service; (5) decreasing 7230 Lease/Rental; (6) creating line**
15 **item 7420 RM Building; and**

16 **WHEREAS, the FY 2016 Hewel Ni'ok CPB CSG Budget Amendment No. 1 will increase the CPB**
17 **CSG FY 2016 Budget of \$265,116.81 by \$18,203.98 of carry forward funds from FY**
18 **2015 to a new total amount of \$283,320.79; and**

19 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have**
20 **reviewed the FY 2016 Hewel Ni'ok CPB CSG Budget Amendment No. 1 and**
21 **recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council approves the**
23 **FY 2016 the Hewel Ni'ok's Corporation for Public Broadcasting Community**
24 **Service Grant Budget Amendment No. 1 effective October 1, 2015 which includes**
25 **an \$18,203.98 of carry forward funds from FY 2015 increasing the overall budget**
26 **from \$265,116.81 to \$283,320.79.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
28 **O'odham Nation chairperson or any designed official is authorized to**
29 **administer and expend the FY 2016 Hewel Ni'ok Corporation for Public**
30 **Broadcasting Community Service Grant Budget as amended, provided however,**



that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).


