

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Rodeo and Fair Program Budget Amendment No. 1)

RESOLUTION NO. 16-253

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY2016 Rodeo and Fair Program Budget in the amount of \$307,132.14 was**
8 **approved by Resolution No. 15-196; and**

9 **WHEREAS, the Rodeo and Fair Program Budget Amendment No. 1 increases the budget in**
10 **the amount of \$120,547.00 from proceeds received from program revenues,**
11 **sponsorship and contributions solicited to support the rodeo and fair event; and**

12 **WHEREAS, the Rodeo and Fair Program has prepared and submitted for review and**
13 **approval its FY 2016 Rodeo and Fair Program Budget Amendment No. 1 which is**
14 **incorporated by this reference and which increases expenses in 6205 Employer**
15 **Health, 6215 Employer Dental, 6750 Award-Rodeo, 7035 Building Materials, 7060**
16 **Food, 7230 Lease/Rentals, 7300 Advertising, 7340 Public Relations, 7355**
17 **Professional Services and 7420 RM Building; and**

18 **WHEREAS, the FY 2016 Rodeo and Fair Program Budget Amendment No. 1 will increase the**
19 **Rodeo Fair FY 2016 budget by \$120,547.00 from \$307,132.14 to \$427,679.14; and**

20 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
21 **have reviewed the FY 2016 Rodeo and Fair Program Budget Amendment No. 1**
22 **and recommend its approval.**


23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2016 Rodeo and Fair Program Budget Amendment No. 1, which includes a**
25 **\$120,547.00 increase from \$307,132.14 to \$427,679.14 that shall be funded by**
26 **program revenue as well as sponsorships and contributions.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
28 **O'odham Nation chairperson or any designated official is authorized to**
29 **administer and expend the FY 2016 Rodeo and Fair Program Budget as**
30 **amended, provided however, that any amendments or modifications shall be**
31 **submitted for further prior approval by the Tohono O'odham Legislative**
32 **Council.**

7 June 18, 1934 (48 Stat.984).
