

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Enrollment Committee Budget Amendment No. 1)

RESOLUTION NO. 16-254

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 Enrollment Committee Budget in the amount of \$46,136.88 was**
8 **approved by Resolution No. 15-165; and**

9 **WHEREAS, the Enrollment Program has prepared and submitted for review and approval**
10 **its FY 2016 Enrollment Committee Budget Amendment No. 1, which is**
11 **incorporated by this reference and which (1) increases line items 6110 FICA and**
12 **line item 7365 Committee fees; (2) decreases line items 6540 Mileage POV, 7060**
13 **Food, and 7355 Professional Services; and**

14 **WHEREAS, the FY 2016 Enrollment Committee Budget Amendment No. 1 will not change the**
15 **total budgeted amount of the FY 2016 Enrollment Committee Budget; and**

16 **WHEREAS, the Rules and Budget and Finance Committees has reviewed the FY 2016**
17 **Enrollment Committee Budget Amendment No. 1 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2016 Enrollment Committee Budget Amendment No. 1 as attached.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
21 **O'odham Nation chairperson or any designated official is authorized to**
22 **administer and expend the FY 2016 Enrollment Committee Budget as amended,**
23 **provided however, that any amendments or modifications shall be submitted**
24 **for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
26 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,770.8 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and 250.6[06] ABSENT, pursuant to the powers vested in the Council**
28 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
31 **Act of June 18, 1934 (48 Stat.984).**
