

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving and Accepting Amendment No. 4 to the Intergovernmental Agreement  
Between the Arizona Department of Economic Security and the Tohono O'odham  
Nation for the Planned Social Services Block Grant Title XX Program)**

**RESOLUTION NO. 16-256**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the authority to "promote, protect and provide for public health, peace,**  
3 **morals, education and general welfare of the Tohono O'odham Nation and its**  
4 **members" and to "consult, negotiate and conclude agreements and contracts on**  
5 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
6 **and other Indian tribes or their departments . . ." (Constitution, Article VI,**  
7 **Section 1(c)(2) and Section 1(f)); and**

8 **WHEREAS, the Tohono O'odham Legislative Council is also authorized "to manage any**  
9 **funds within the exclusive control of the Tohono O'odham Nation . . . and to**  
10 **appropriate these funds for the benefit of the nation and its members" provided**  
11 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
12 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
13 **O'odham Nation, Article VI, section 1(d)(2)); and**

14 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**  
15 **affordability, and quality of child care through funding provided by the Arizona**  
16 **Department of Economic Security ("ADES") Planned Social Services Block Grant**  
17 **Title XX Program; and**

18 **WHEREAS, the Tohono O'odham Nation has entered into a cost-reimbursement**  
19 **Intergovernmental Agreement ("IGA") with ADES for the Planned Social Services**  
20 **Block Grant Title XX Program pursuant to Resolution No. 13-256, Contract**  
21 **Number ADES14-053077; and**

22 **WHEREAS, Amendment No. 4 amends the IGA to provide that for the period of July 1, 2016,**  
23 **though June 30, 2017, the contract reimbursement ceiling is \$99,612.00; and**

24 **WHEREAS, the Itemized Service Budget for the period of July 1, 2016, through June 30, 2017,**  
25 **is attached and added to this Agreement; and**

26 **WHEREAS, the Human Resources Development Committee of the Tohono O'odham**  
27 **Legislative Council has reviewed Amendment No. 4 to the Intergovernmental**  
28 **Agreement between the Arizona Department of Economic Security and the**  
29 **Tohono O'odham Nation for the Planned Social Services Block Grant Title XX**  
30 **Program and recommends its approval.**

1 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
2 **and accepts Amendment No. 4 to the Intergovernmental Agreement between the**  
3 **Arizona Department of Economic Security and the Tohono O'odham Nation for**  
4 **the Planned Social Services Block Grant Title XX Program, Contract Number**  
5 **ADES14-053077.**

6 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs**  
7 **the Chairperson of the Tohono O'odham Nation to execute Amendment No. 4 to**  
8 **the Intergovernmental Agreement between the Arizona Department of**  
9 **Economic Security and the Tohono O'odham Nation for the Planned Social**  
10 **Services Block Grant Title XX Program, provided that any additional**  
11 **amendments to the IGA shall be submitted for prior approval by the Tohono**  
12 **O'odham Legislative Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
14 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
16 **Article VI, Section 1(d)(2), Section 1(c)(2), and Section 1(f) of the Constitution of the Tohono**  
17 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
18 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
19 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




