

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2017 Child Care Services Title XX Budget)**

**RESOLUTION NO. 16-257**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to  
3 appropriate these funds for the benefit of the nation and its members" provided  
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or  
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono  
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** Child Care Services provide services to improve the availability, affordability,  
8 and quality of child care through funding provided by the Arizona Department  
9 of Economic Security ("AZDES") Planned Social Services Block Grant Title XX  
10 Program; and

11 **WHEREAS,** the AZDES and the Tohono O'odham Nation ("Nation") negotiated an  
12 intergovernmental agreement by which the Nation receives an AZDES Planned  
13 Social Services Block Grant Title XX Program in the amount of \$99,612.00 to  
14 reimburse the Nation for its Title XX expenses for a period beginning July 1, 2016  
15 through June 30, 2017; and

16 **WHEREAS,** Child Care Services has prepared and submitted for review and approval its FY  
17 2017 Child Care Services Title XX Budget, which is incorporated by this  
18 reference, in the amount of \$99,612.00; and

19 **WHEREAS,** the Human Resources Development and the Budget and Finance Committees  
20 have reviewed the FY 2017 Child Care Services Title XX Budget and recommend  
21 its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
23 FY 2017 Child Care Services Title XX Budget in the amount of \$99,612.00 and  
24 authorizes the use of the Nation's resources pending reimbursement from the  
25 Grantor for the continuation of the grant.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
27 O'odham Nation chairperson or any designated official is authorized and  
28 directed to administer and expend the FY 2017 Child Care Services Title XX  
29 Budget, provided however, that any amendments or modifications affecting the  
30 funds or funding levels shall be submitted for further prior approval by the  
31 Tohono O'odham Legislative Council.

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>  
2 day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-  
3 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
4 Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the  
5 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
6 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
7 June 18, 1934 (48 Stat.984).
