8		Juvenile Immigration Status filings on behalf of Mexican National O'odham

10	WHEREAS,	the Office of Attorney General has recommended an attorney contract with the					
11		Law Office of Juan C. Flamand, PLLC for FY 2016 for the period from October 1,					
12		2015 to September 30, 2016 to be funded by the FY 2016 Office of Attorney

14	WHEREAS,	the Domestic Affairs Committee has reviewed the Attorney Contract with the Law					
15		Office of Juan C. Flamand, PLLC and recommends approval by the Legislative
