

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract for FY 2016 with the Law Office of Juan C. Flamand, PLLC)**

**RESOLUTION NO. 16-258**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**  
2 **with the power to "employ legal counsel for the protection and advancement of**  
3 **the rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**  
4 **Nation, Article VI, Section 2 (a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the Law Office of**  
6 **Juan C. Flamand, PLLC to provide legal advice and representation to the Tohono**  
7 **O'odham Nation's Office of Attorney General in matter relating to Special**  
8 **Juvenile Immigration Status filings on behalf of Mexican National O'odham**  
9 **children who are wards of the Tohono O'odham Children's Court; and**

10 **WHEREAS, the Office of Attorney General has recommended an attorney contract with the**  
11 **Law Office of Juan C. Flamand, PLLC for FY 2016 for the period from October 1,**  
12 **2015 to September 30, 2016 to be funded by the FY 2016 Office of Attorney**  
13 **General Budget; and**

14 **WHEREAS, the Domestic Affairs Committee has reviewed the Attorney Contract with the Law**  
15 **Office of Juan C. Flamand, PLLC and recommends approval by the Legislative**  
16 **Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **Attorney Contract with the Law Office of Juan C. Flamand, PLLC for FY 2016 in**  
19 **substantially the form attached and authorizes the chairperson of the Nation to**  
20 **execute it.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
22 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,417.6 FOR; 603.8**  
23 **AGAINST; [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
24 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
27 **June 18, 1934 (48 Stat.984).**
