4		that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5		budgets" authorized by resolution or ordinance (Constitution of the Tohono
6		O'odham Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the Constitution of the Tohono O'odham Nation also vests the Legislative
8		Council with the authority to "adopt, approve and amend annual budgets and to
9		authorize the expenditure of funds in accordance with these budgets
10		(Constitution, Article VI, Section 1(d)(3)); and
11	WHEREAS,	the FY 2016 Legislative Branch Budget in the amount of \$3,318,850.13 was
12		approved by Resolution No. 15-166; and
13	WHEREAS,	the Legislative Branch has prepared and submitted for review and approval its
14		FY 2016 Budget Amendment No. 3, which is incorporated by this reference and
15		which (1) increases expenses in 6540 Mileage POV, 7060 Food, 7230
16		Lease/Rentals, 7340 Public Relations, and 7618 Honorariums, and (2) decreases
17		line items 6110 FICA, 7000 Supplies - Office, 7365 Committee Fees, 7500 Major
18		Capital, and 8060 Alteration and Renovations; and
19	WHEREAS,	the FY 2016 Legislative Branch Budget Amendment No. 3 will not increase the
20		Legislative Branch FY 2016 Budget; and
21	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2016 Legislative Branch
22		Budget Amendment No. 3 and recommends its approval.
23	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
24		FY 2016 Legislative Branch Budget Amendment No. 3.
25	BE IT FINAL	LLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
26		O'odham Legislative Branch Chairperson and Vice-Chairperson are authorized
27		to administer and expend the FY 2016 Legislative Branch Budget as amended,
28		provided however, that any amendments or modifications shall be submitted
29		for prior approval by the Tohono O'odham Legislative Council.
