

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting June 24, 2016 Special Session to Review Tohono O'odham Nation Basic
Statements and Independent Auditors' Report)

LEGISLATIVE ORDER NO. 16-262

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**
6 **with the authority to "by majority vote, call for a special session" (Legislative**
7 **Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Budget and Finance Committee has requested a special session on June 24,**
9 **2016 to review Tohono O'odham Nation basic statements and independent**
10 **auditors' report and to recognize staff.**

11 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
12 **special session on June 24, 2016 at 1:00 p.m. to review Tohono O'odham Nation**
13 **basic statements and independent auditors' report and to recognize staff.**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 17TH day of**
15 **JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST;**
16 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
17 **Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
18 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
19 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
20 **Stat.984).**
