

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY 2016 with the Law Firm of Dentons US, LLP)

RESOLUTION NO. 16-267

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the power to "employ legal counsel for the protection and advancement of**
3 **the rights of the Tohono O'odham Nation" (Constitution of the Tohono O'odham**
4 **Nation, Article VI, Section 2(a)); and**

5 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of**
6 **Dentons US, LLP to represent the Tohono O'odham Nation in matters relating to**
7 **the Cooperative Fund; and**

8 **WHEREAS, the Attorney General has recommended an attorney contract with Dentons US**
9 **LLP for FY 2016, for the period from June 1, 2016 to September 30, 2016 to be**
10 **funded by the FY 2016 Office of Attorney General SAWRSA Budget; and**

11 **WHEREAS, the Domestic Affairs and Water Resources Committees have reviewed the**
12 **Attorney Contract for FY 2016 with the Law Firm of Dentons US, LLP and**
13 **recommend its approval by the Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **Attorney Contract for FY 2016 with the law firm of Dentons US, LLP for FY 2016**
16 **and authorizes the chairperson of the Tohono O'odham Nation to execute it in**
17 **substantially the form attached hereto.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
19 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,918.5 FOR; 102.9**
20 **AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by**
21 **Article VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
22 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
24 **June 18, 1934 (48 Stat.984).**


