

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2016 Head Start Tribal Match Budget Amendment No. 1)**

**RESOLUTION NO. 16-268**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d) (2)); and**

7 **WHEREAS, the FY 2016 Head Start Tribal Match Budget in the amount of \$501,175.78 was**  
8 **approved by Resolution No. 15-165; and**

9 **WHEREAS, the Division of Early Childhood Development has prepared and submitted for**  
10 **review and approval its FY 2016 Head Start Tribal Match Budget Amendment No.**  
11 **1, which is incorporated by this reference and which (1) increases and decreases**  
12 **Operational Expenses; and (2) corrects a Salary and Grade/Step underfunding**  
13 **error for the position of Cook; and**

14 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
15 **reviewed the FY 2016 Head Start Tribal Match Budget Amendment No. 1 and**  
16 **recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2016 Head Start Tribal Match Budget Amendment No. 1 in the amount of**  
19 **\$501,175.78 as attached.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
21 **O'odham Nation chairperson or any designated official is authorized to**  
22 **administer and expend the FY 2016 Head Start Tribal Match Budget as amended,**  
23 **provided however, that any amendments or modifications shall be submitted**  
24 **for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>**  
26 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
31 **June 18, 1934 (48 Stat.984).**
