14	WHEREAS,	the First Things First Tohono O'odham Nation Regional Council has awarded the
15		Tohono O'odham Nation Division of Early Childhood Development a second year
16		grant in the amount of \$50,000.00 through a grant renewal amendment; and
17	WHEREAS,	the Tohono O'odham Nation Division of Early Childhood Development has
18		prepared and submitted for review its FY 2017 First Things First Budget, which is
19		incorporated by this reference; and
20	WHEREAS,	the Human Resources Development and the Budget and Finance Committees of
21		the Tohono O'odham Legislative Council have reviewed the First Things First
22		Grant Renewal Amendment and FY 2017 First Things First Budget and
23		recommend its approval.
