

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving First Things First Grant No. GRA-RC026-16-0770-01-Y2
and the FY 2017 First Things First Budget)

RESOLUTION NO. 16-269

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to consult, negotiate and**
8 **conclude agreements and contracts on behalf of the Tohono O'odham Nation**
9 **with Federal, State and local governments and other Indian tribes or their**
10 **departments, agencies, or political subdivisions" (Constitution of the Tohono**
11 **O'odham Nation, Article VI, Section 1(f)); and**

12 **WHEREAS, the FY 2016 First Things First Intergovernmental Agreement ("IGA") was**
13 **approved by Resolution No. 15-258; and**

14 **WHEREAS, the First Things First Tohono O'odham Nation Regional Council has awarded the**
15 **Tohono O'odham Nation Division of Early Childhood Development a second year**
16 **grant in the amount of \$50,000.00 through a grant renewal amendment; and**

17 **WHEREAS, the Tohono O'odham Nation Division of Early Childhood Development has**
18 **prepared and submitted for review its FY 2017 First Things First Budget, which is**
19 **incorporated by this reference; and**

20 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
21 **the Tohono O'odham Legislative Council have reviewed the First Things First**
22 **Grant Renewal Amendment and FY 2017 First Things First Budget and**
23 **recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
25 **accepts and approves the First Things First Grant No. GRA-RC026-16-0770-01-Y2**
26 **Grant Renewal Amendment effective July 1, 2016 through June 30, 2017 and the**
27 **FY 2017 First Things First Budget in the amount of \$50,000.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
29 **Chairperson and any designated official to implement the First Things First**
30 **Grant Renewal Amendment provided that any amendments or modifications**


3 **BE IT FINALLY RESOLVED** that the Tohono O'odham Legislative Council that the Tohono
4 O'odham Nation chairperson or any designated official is authorized to
5 administer and expend the FY 2017 First Things First Budget, provided however,
6 that any amendments or modifications shall be submitted for prior approval by
7 the Tohono O'odham Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST
9 day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-
10 AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by
11 Article VI, Section 1(d)(2)&(3) and 1(f) of the Constitution of the Tohono O'odham Nation,
12 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
13 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
14 16 of the Act of June 18, 1934 (48 Stat.984).


