11	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
12		reviewed the Title III Caregiver Information & Referral and Caregiver Training
13		Budgets and recommend their approval.

18		to June 30, 2016 and to utilize the Nation's resources pending reimbursement
