	with Federal, State and local governments (Constitution of the Tohono
	O'odham Nation, Article VI, Section 1(f)); and
WHEREAS,	on February 17, 2016, the Legislative Council approved a model form of the
	Intergovernmental Personnel Act Agreement ("IPA") and authorized the
	Chairperson of the Nation to execute appropriate agreements with Indian
	Health Service ("IHS") employees, which would only take effect pursuant to an
	authorized self-governance compact with the U.S. Department of Health and
	Human Services, Indian Health Service (Resolution No. 16-075); and
WHEREAS,	the IPAs signed by IHS employees and provided to the Nation by IHS contain
	language not originally in the form IPA approved by Legislative Council
	Resolution No. 16-075; and
WHEREAS,	the additional language requires the Nation to agree that it will require, as a
	condition of direct hire of an employee, that the employee voluntarily resign
	from federal service and if the employee fails to resign, any offer of direct hire
	be rescinded; and
WHEREAS,	the Health and Human Services Committee has reviewed the amended IPA and
	recommends its approval.
NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
	amended IPA substantially in the form attached and authorizes and directs the
	Tohono O'odham Nation Chairperson or any designated official to execute the
	IPA with Indian Health Service employees.
