

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amended Intergovernmental Personnel Act Agreement to Accept Additional**  
**Language Proposed by Indian Health Service)**

**RESOLUTION NO. 16-272**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to consult, negotiate and**  
2 **conclude agreements and contracts on behalf of the Tohono O'odham Nation**  
3 **with Federal, State and local governments... (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(f)); and**

5 **WHEREAS, on February 17, 2016, the Legislative Council approved a model form of the**  
6 **Intergovernmental Personnel Act Agreement ("IPA") and authorized the**  
7 **Chairperson of the Nation to execute appropriate agreements with Indian**  
8 **Health Service ("IHS") employees, which would only take effect pursuant to an**  
9 **authorized self-governance compact with the U.S. Department of Health and**  
10 **Human Services, Indian Health Service (Resolution No. 16-075); and**

11 **WHEREAS, the IPAs signed by IHS employees and provided to the Nation by IHS contain**  
12 **language not originally in the form IPA approved by Legislative Council**  
13 **Resolution No. 16-075; and**

14 **WHEREAS, the additional language requires the Nation to agree that it will require, as a**  
15 **condition of direct hire of an employee, that the employee voluntarily resign**  
16 **from federal service and if the employee fails to resign, any offer of direct hire**  
17 **be rescinded; and**

18 **WHEREAS, the Health and Human Services Committee has reviewed the amended IPA and**  
19 **recommends its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **amended IPA substantially in the form attached and authorizes and directs the**  
22 **Tohono O'odham Nation Chairperson or any designated official to execute the**  
23 **IPA with Indian Health Service employees.**


24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>**  
25 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
30 **June 18, 1934 (48 Stat.984).**




