

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Indirect Cost Programs Self-Governance Budgets)**

RESOLUTION NO. 16-273

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Treasurer, Accounting Department, Human Resources Department,**
8 **Department of Information and Technology, Facilities Management, and the**
9 **Department of Planning and Economic Development have prepared and**
10 **submitted for review and approval FY 2016 Indirect Cost Programs Self-**
11 **governance Budgets, which are incorporated by this reference, in the amounts**
12 **identified in the table below to be funded by the Contract Support Cost ("CSC")**

24 **WHEREAS, the Health and Human Services, as the primary oversight Committee, Human**
25 **Resources Development, Commerce, and Budget and Finance Committees have**
26 **reviewed their respective FY 2016 Indirect Cost Programs Self-Governance**
27 **Budgets and recommend approval.**

28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
29 **FY 2016 Indirect Cost Programs Self-Governance Budgets in the total amount of**
30 **\$3,866,648.20 effective July 1, 2016, which shall be funded by the CSC Proposal.**

1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
2 O'odham Nation Chairperson or any designated official is authorized and
3 directed to administer and expend the FY 2016 Indirect Cost Programs Self-
4 Governance Budgets, provided that any amendments or modifications shall be
5 submitted for prior approval by the Tohono O'odham Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND
7 day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,499.65 FOR;
8 521.75 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the
9 Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation,
10 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
11 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
12 16 of the Act of June 18, 1934 (48 Stat.984).


