

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2016 Department of Health and Human Services, Department of Public Safety, and Department of Information and Technology Self-Governance Budgets)**

**RESOLUTION NO. 16-275**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**  
3 **appropriate these funds for the benefit of the nation and its members" provided**  
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**  
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**  
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services, Department of Public Safety,**  
8 **and Department of Information and Technology have prepared and submitted**  
9 **for review and approval their FY 2016 Self-Governance Budgets for the period**  
10 **beginning July 1, 2016 and ending on September 30, 2016 and Schedule A, which**  
11 **are incorporated by this reference, in the total amounts of:**

**Department of Health and Human Services-\$25,492,081.54**

**Department of Public Safety-\$1,148,116.13**

**Department of Information and Technology-\$139,659.65; and**

15 **WHEREAS, the Health and Human Services, as the primary oversight Committee, Domestic**  
16 **Affairs, and the Budget and Finance Committees of the Legislative Council have**  
17 **reviewed the FY 2016 Department of Health and Human Services, Department of**  
18 **Public Safety, and Department of Information and Technology Self-Governance**  
19 **Budgets and recommend approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2016 Self-Governance Budgets for the:**

**Department of Health and Human Services-\$25,492,081.54;**

**Department of Public Safety-EMS Security Dispatch \$1,148,116.13; and**

**Department of Information and Technology-Third Party \$139,659.65;**

25 **effective July 1, 2016 in the total amount of \$26,779,857.32, which shall be funded**  
26 **by the Indian Health Services and third party revenues, as attached hereto**  
27 **(Schedule A).**

28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
29 **O'odham Nation Chairperson or any designated official is authorized and**




**Human Services, Department of Public Safety, and Department of Information and Technology Self-Governance Budgets, provided, that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 2,152.6 FOR; \$68.8 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**






