

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2016 Schuk Toak District-Santa Rosa Ranch Community**  
**Budget Amendment No. 1)**

**RESOLUTION NO. 16-277**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only  
6 by a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.; and

11 **WHEREAS,** the FY 2016 Schuk Toak District Budget in the amount of \$4,319,085.80 was  
12 authorized by Schuk Toak District Council Resolution No. ST-08-31-15-067 and  
13 approved by Legislative Council Resolution No. 15-382; and

14 **WHEREAS,** by Schuk Toak District Council Resolution No. ST-06-16-16-043 the Schuk Toak  
15 District has prepared and submitted for review and approval its FY 2016 Budget  
16 Amendment No. 1, which is incorporated by this reference and which (1)  
17 increases and decreases operational line items; (2) amends line item  
18 descriptions for 7000 Supplies-Office, 7005 Supplies-Office Equipment, 7035  
19 Building Material, 7045 Animal Supplies, 7230 Lease/Rentals, 7610 Clothing  
20 Allowance and 7615 Donation/Contribution; and

21 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2016 Schuk Toak  
22 District-Santa Rosa Ranch Community Budget Amendment No. 1 and  
23 recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2016 Schuk Toak District-Santa Rosa Ranch Community Budget Amendment  
26 No. 1 as attached.

27 **BE IT FURTHER RESOLVED** that this amendment will not alter the FY 2016 Schuk Toak District-  
28 Santa Rosa Ranch Community total budgeted amount of \$189,119.96.

29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2016 Schuk  
30 Toak District-Santa Rosa Ranch Community Budget as amended shall be  
31 managed and expended in accordance with Article IX, Section 7 of the

1 Constitution of the Tohono O'odham Nation and the Nation's laws, provided that  
2 any amendments or modifications shall be authorized under District Council  
3 resolution and submitted for prior approval by the Tohono O'odham Legislative  
4 Council.

5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup>  
6 day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-  
7 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
8 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
9 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
10 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
11 (48 Stat.984).




