

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Tohono O'odham Gaming Office-West Valley Resort
Budget Amendment No. 1)

RESOLUTION NO. 16-278

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to
3 appropriate these funds for the benefit of the nation and its members" provided
4 that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2016 Tohono O'odham Gaming Office-West Valley Resort Budget in the
8 amount of \$2,100,544.76 was approved by Resolution No. 15-160; and

9 **WHEREAS,** the FY 2016 Tohono O'odham Gaming Office-West Valley Resort Budget
10 Amendment No. 1 corrects salaries for the Office Specialist and Director of
11 Gaming resulting in retro pay being due; and

12 **WHEREAS,** the Tohono O'odham Gaming Office has prepared and submitted for review and
13 approval its FY 2016 Budget Amendment No. 1, which is incorporated by this
14 reference and which (1) adds six new positions to alleviate understaffing at
15 Tohono O'odham Gaming Office-West Valley Resort and thereby increases
16 Personnel line item expenses and (2) decreases Operational line item expenses
17 and (3) corrects salaries for the Office Specialist and Director of Gaming
18 retroactive to October 1, 2015; and

19 **WHEREAS,** the FY 2016 Tohono O'odham Gaming Office-West Valley Resort Budget
20 Amendment No. 1 will increase the Tohono O'odham Gaming Office-West Valley
21 Resort FY 2016 Budget by \$106,581.60 from \$2,100,544.76 to \$2,207,126.36; and

22 **WHEREAS,** the Commerce and Budget and Finance Committees have reviewed the FY 2016
23 Tohono O'odham Gaming Office-West Valley Resort Budget Amendment No. 1
24 and recommend its approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2016 Tohono O'odham Gaming Office-West Valley Resort Budget Amendment
27 No. 1 effective October 1, 2015, which includes a \$106,581.60 increase from
28 \$2,100,544.76 to \$2,207,126.36 that shall be funded from the Nation's General
29 Fund.

3 **directed to administer and expend the FY 2016 Tohono O'odham Gaming Office-**
4 **West Valley Resort Budget as amended, provided however, that any**
5 **amendments or modifications shall be submitted for prior approval by the**
6 **Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24th**
8 **day of JUNE, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
10 **Article VI, Section 1(d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by**
11 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
13 **June 18, 1934 (48 Stat.984).**
