

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

**RESOLUTION NO. 16-281**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications and**  
7 **making recommendations to the Legislative Council regarding the eligibility of**  
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**  
10 **O'odham Legislative Council shall determine whether an application is approved**  
11 **for membership and its determination, along with the resolution number and**  
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**  
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**  
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 55-81, 308-**  
17 **89, 91-308, 93-305, 01-050, 02-180, 02-280, 05-114, 05-368, 08-411, 09-330, 12-344,**  
18 **13-391 and 15-017 be amended to reflect the amended names for the members**  
19 **identified in the July 2016 Amended Enrollment Resolution Summary, which is**  
20 **incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 55-81, 308-89, 91-308, 93-305, 01-050, 02-180, 02-280, 05-114, 05-368, 08-411,**  
23 **09-330, 12-344, 13-391 and 15-017 are amended upon the effective date of those**  
24 **resolutions to reflect the legal name changes for the members identified in the**  
25 **July 2016 Amended Enrollment Resolution Summary.**




