

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting July 20, 2016 Special Session at West Valley Resort for a Tour)

LEGISLATIVE ORDER NO. 16-288

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**
6 **with the authority to "by majority vote, call for a special session" (Legislative**
7 **Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, Article I, Section 2(C) of the Legislative Rules, as amended, provides that "[a]ll**
9 **Legislative Council sessions shall be held at the Tohono O'odham Legislative**
10 **Council chambers located in Sells, Tohono O'odham Nation, with the following**
11 **exceptions. . . [a] majority of all the legislative representatives may vote to hold a**
12 **session in some location other than the chambers located at Sells."; and**

13 **WHEREAS, the Commerce Committee has requested a special session on July 20, 2016 at West**
14 **Valley Resort for a tour beginning at 9:00 a.m.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**
16 **special session on July 20, 2016 at West Valley Resort for a tour.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11th day of**
18 **JULY, 2016 at a meeting at which a quorum was present with a vote of 2,674.35 FOR; 347.05**
19 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
20 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
21 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat.984).**
