

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Setting July 25-28, 2016 Special Session to Review the Nation's FY 2017 Budgets)**

LEGISLATIVE ORDER NO. 16-289

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council**
6 **with the authority to "by majority vote, call for a special session" (Legislative**
7 **Rules of the Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Budget and Finance Committee has requested a July 25-28, 2016 special**
9 **session to review the Nation's FY 2017 budgets.**

10 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a July**
11 **25-28, 2016 special session to review the Nation's FY 2017 budgets.**

12 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11TH day of**
13 **JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0- AGAINST;**
14 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**
15 **Section 1(a)and(d) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
16 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
