

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2016 Enrollment Committee Budget Amendment No. 2)**

**RESOLUTION NO. 16-292**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2016 Enrollment Committee Budget in the amount of \$46,136.88 was**  
8 **approved by Resolution No. 15-165; and**

9 **WHEREAS, the Enrollment Program has prepared and submitted for review and approval**  
10 **its FY 2016 Enrollment Committee Budget Amendment No. 2, which is**  
11 **incorporated by this reference and which increases line items 6110 FICA and**  
12 **line item 7365 Committee Fees; and**

13 **WHEREAS, the FY 2016 Enrollment Committee Budget Amendment No. 2 will increase the FY**  
14 **2016 Enrollment Committee Budget by \$16,828.12 from \$46,136.88 to \$62,965.00;**  
15 **and**


16 **WHEREAS, the Rules and Budget and Finance Committees have reviewed the FY 2016**  
17 **Enrollment Committee Budget Amendment No. 2 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2016 Enrollment Committee Budget Amendment No. 2 effective October 1,**  
20 **2015, which includes a \$16,828.12 increase from \$46,136.88 to \$62,965.00 that**  
21 **shall be funded by the general fund surplus.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
23 **O'odham Nation chairperson or any designated official is authorized to**  
24 **administer and expend the FY 2016 Enrollment Committee Budget as amended,**  
25 **provided however, that any amendments or modifications shall be submitted**  
26 **for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
28 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021,4 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
33 **June 18, 1934 (48 Stat.984).**


