

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Professional Services Agreement between the Tohono O'odham
Nation and Intermountain Centers for Human Development, Inc.)**

RESOLUTION NO. 16-293

1 **WHEREAS, the Professional Services Agreement between the Tohono O'odham Nation**
2 **("Nation") and Intermountain Centers for Human Development, Inc.**
3 **("Intermountain") will allow Intermountain to provide residential and foster**
4 **care services for the Nation's Children In Need of Care for the period of October**
5 **1, 2015 to September 30, 2016; and**

6 **WHEREAS, the agreement is in excess of \$500,000.00, and so has been reviewed by the Office**
7 **of Attorney General as required by law; and**

8 **WHEREAS, the funding for this agreement will come from Tribal Child Welfare budget 001-**
9 **16-6051; and**

10 **WHEREAS, the Health and Human Services Committee has reviewed the agreement as**
11 **attached, and recommend approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the Professional Services Agreement between the Tohono O'odham**
14 **Nation and Intermountain Centers for Human Development, Inc., as attached,**
15 **and authorizes the Executive Branch to expend funds as budgeted.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairperson is authorized to**
17 **execute the Professional Services Agreement, provided that any amendments**
18 **shall be submitted for prior approval by the Tohono O'odham Legislative**
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
21 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1(c)(2), 1(d)(3), and 1(f) of the Constitution of the Tohono O'odham Nation,**
24 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
25 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
26 **16 of the Act of June 18, 1934 (48 Stat.984).**
