5	WHEREAS,	Chairman Edward Manuel has identified Regina M. Sixkiller as the appointee for
6		the Nation's chief administrative officer; and
7	WHEREAS,	pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono
8		O'odham Legislative Council, the chairperson's "appointee to the position of
9		treasurer or other officers or heads of governmental departments shall not be
10		added to any Legislative Council session agenda for approval unless the
11		appropriate legislative committee interviews the appointee after receiving a
12		resume and written background investigation report" containing detailed
13		employment, education, credit, litigation, and other information necessary to
14		determine the appointee's qualifications and fitness; and
15	WHEREAS,	the Legislative Council Budget and Finance Committee has received and
16		reviewed the detailed written background investigation report required by the
17		Legislative Rules, interviewed the appointee, and recommends that the
18		Legislative Council approve the appointment.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		appointment of Regina M. Sixkiller as the Nation's chief administrative officer;
21		provided that Regina M. Sixkiller shall serve until replaced at the request of the
22		Nation's chairperson.
