

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Marietta Martin as Department of Education  
Executive Director)**

**DEFEATED  
RESOLUTION NO. 16-302**

1   **WHEREAS, Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation vests**  
2                   **the Nation's chairperson with authority to appoint the Nation's treasurer, and**  
3                   **other officers and heads of all governmental departments with the approval of**  
4                   **the Tohono O'odham Legislative Council; and**

5   **WHEREAS, Chairman Edward Manuel has identified Marietta Martin as the appointee for the**  
6                   **Department of Education Executive Director; and**

7   **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**  
8                   **O'odham Legislative Council, the chairperson's "appointee to the position of**  
9                   **treasurer or other officers or heads of governmental departments shall not be**  
10                  **added to any Legislative Council session agenda for approval unless the**  
11                  **appropriate legislative committee interviews the appointee after receiving a**  
12                  **resume and written background investigation report" containing detailed**  
13                  **employment, education, credit, litigation, and other information necessary to**  
14                  **determine the appointee's qualifications and fitness; and**

15   **WHEREAS, the Legislative Council Human Resources Development Committee has received**  
16                  **and reviewed the detailed written background investigation report required by**  
17                  **the Legislative Rules, interviewed the appointee.**

18   **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19                  **appointment of Marietta Martin as Department of Education Executive Director;**  
20                  **provided that Marietta Martin shall serve until replaced at the request of the**  
21                  **Nation's chairperson.**

22   **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
23   **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 1,327.6 FOR; 1,693.8**  
24   **AGAINST; -0- NOT VOTING and [01] ABSENT, pursuant to the powers vested in the Council by**  
25   **Article VI, Section 1(d) and Article VII, Section 2(e) of the Constitution of the Tohono O'odham**  
26   **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
27   **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
28   **16 of the Act of June 18, 1934 (48 Stat.984).**
