12		appropriate legislative committee interviews the appointee after receiving a
		resume and written background investigation report" containing detailed
13		employment, education, credit, litigation, and other information necessary to
14		determine the appointee's qualifications and fitness; and
15	WHEREAS,	the Legislative Council Eric Hager Committee has received and reviewed the
16		detailed written background investigation report required by the Legislative
17		Rules, interviewed the appointee, and recommends that the Legislative Council
18		approve the appointment.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		appointment of Eric Hager as Gaming Office Executive Director; provided that
21		Eric Hager shall serve until replaced at the request of the Nation's chairperson.
