

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Appointment of Eric Hager as Gaming Office Executive Director)**

**DEFEATED  
RESOLUTION NO. 16-304**

1 **WHEREAS, Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation vests**  
2 **the Nation's chairperson with authority to appoint the Nation's treasurer, and**  
3 **other officers and heads of all governmental departments with the approval of**  
4 **the Tohono O'odham Legislative Council; and**

5 **WHEREAS, Chairman Edward Manuel has identified Eric Hager as the appointee for the**  
6 **Gaming Office Executive Director; and**

7 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**  
8 **O'odham Legislative Council, the chairperson's "appointee to the position of**  
9 **treasurer or other officers or heads of governmental departments shall not be**  
10 **added to any Legislative Council session agenda for approval unless the**  
11 **appropriate legislative committee interviews the appointee after receiving a**  
12 **resume and written background investigation report" containing detailed**  
13 **employment, education, credit, litigation, and other information necessary to**  
14 **determine the appointee's qualifications and fitness; and**

15 **WHEREAS, the Legislative Council Eric Hager Committee has received and reviewed the**  
16 **detailed written background investigation report required by the Legislative**  
17 **Rules, interviewed the appointee, and recommends that the Legislative Council**  
18 **approve the appointment.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **appointment of Eric Hager as Gaming Office Executive Director; provided that**  
21 **Eric Hager shall serve until replaced at the request of the Nation's chairperson.**

22 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
23 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 720.65 FOR; 2,300.75**  
24 **AGAINST; -0- NOT VOTING and -0- ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(d) and Article VII, Section 2(e) of the Constitution of the Tohono O'odham**  
26 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
27 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
28 **16 of the Act of June 18, 1934 (48 Stat.984).**
