

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Shawn Carlos as Department of Human Resources Executive Director)

RESOLUTION NO. 16-309

1 **WHEREAS, Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation vests**
2 **the Nation's chairperson with authority to appoint the Nation's treasurer, and**
3 **other officers and heads of all governmental departments with the approval of**
4 **the Tohono O'odham Legislative Council; and**

5 **WHEREAS, Chairman Edward Manuel has identified Shawn Carlos as the appointee for the**
6 **Department of Human Resources Executive Director; and**

7 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
8 **O'odham Legislative Council, the chairperson's "appointee to the position of**
9 **treasurer or other officers or heads of governmental departments shall not be**
10 **added to any Legislative Council session agenda for approval unless the**
11 **appropriate legislative committee interviews the appointee after receiving a**
12 **resume and written background investigation report" containing detailed**
13 **employment, education, credit, litigation, and other information necessary to**
14 **determine the appointee's qualifications and fitness ; and**

15 **WHEREAS, the Legislative Council Human Resources Development Committee has received**
16 **and reviewed the detailed written background investigation report required by**
17 **the Legislative Rules and interviewed the appointee.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **appointment of Shawn Carlos as Department of Human Resources Executive**
20 **Director; provided that Shawn Carlos shall serve until replaced at the request of**
21 **the Nation's chairperson.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
23 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 2,037.1 FOR; 984.3**
24 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d) and Article VII, Section 2(e) of the Constitution of the Tohono O'odham**
26 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**
27 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
28 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**






