

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Endorsing Hillary Clinton for President of the United States)**

RESOLUTION NO. 16-313

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the authority to "consult, negotiate and conclude agreements and**
3 **contracts on behalf of the Tohono O'odham Nation with federal, state and local**
4 **governments" and to "promote, protect and provide for public health, peace,**
5 **morals, education and general welfare of the Tohono O'odham Nation and its**
6 **members" (Constitution, Article VI, Section 1(f) and Section 1(c)(2)); and**

7 **WHEREAS, in November 2016, the United States will hold a general election to elect the next**
8 **President of the United States; and**

9 **WHEREAS, the Tohono O'odham Nation consults regularly with the federal government on a**
10 **wide variety of issues that directly affect the Nation's members; and**

11 **WHEREAS, although the Nation encourages its members to vote as they deem appropriate,**
12 **it is in the Nation's best interests to identify a qualified candidate for office of**
13 **the President of the United States who is most closely aligned with furthering the**
14 **Nation's objectives; and**

15 **WHEREAS, several members of the Nation's elected leadership, the Nation's chairperson,**
16 **Legislative Council vice-chairperson, and Legislative Council representatives**
17 **plan to attend the 2016 Democratic National Convention July 25-28 in**
18 **Philadelphia, PA, where the Democratic Party will officially nominate a**
19 **candidate for the office of the President of the United States; and**

20 **WHEREAS, the Appropriations Committee recommends endorsing Hillary Clinton for the**
21 **office of the President of the United States.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
23 **endorses and supports Hillary Clinton for the office of President of the United**
24 **States.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
26 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 2,792.8 FOR; 228.6**
27 **AGAINST; [03] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(f) and Section 1(c)(2) of the Constitution of the Tohono O'odham Nation,**
29 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
30 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
31 **16 of the Act of June 18, 1934 (48 Stat.984).**
