

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Marlakay Henry as Department of Natural
Resources Executive Director)**

**DEFEATED
RESOLUTION NO. 16-314**

1 **WHEREAS, Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation vests**
2 **the Nation's chairperson with the authority to appoint the Nation's treasurer, and**
3 **other officers and heads of all governmental departments with the approval of**
4 **the Tohono O'odham Legislative Council; and**

5 **WHEREAS, Chairman Edward Manuel has identified Marlakay Henry as the appointee for the**
6 **Department of Natural Resources executive director; and**

7 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
8 **O'odham Legislative Council, the chairperson's "appointee to the position of**
9 **treasurer or other officers or heads of governmental departments shall not be**
10 **added to any Legislative Council session agenda for approval unless the**
11 **appropriate legislative committee interviews the appointee after receiving a**
12 **resume and written background investigation report" containing detailed**
13 **employment, education, credit, litigation, and other information necessary to**
14 **determine the appointee's qualifications and fitness; and**

15 **WHEREAS, the Legislative Council Agriculture and Natural Resources Committee has**
16 **received and reviewed the detailed written background investigation report**
17 **required by the Legislative Rules and interviewed the appointee.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **appointment of Marlakay Henry as Department of Natural Resources executive**
20 **director; provided that Marlakay Henry shall serve until replaced at the request**
21 **of the Nation's chairperson.**

22 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 21ST**
23 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 1,503.85 FOR;**
24 **1,517.55 AGAINST; -0- NOT VOTING and [04] ABSENT, pursuant to the powers vested in the**
25 **Council by Article VI, Section 1(d) and Article VII, Section 2(e) of the Constitution of the Tohono**
26 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**
27 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**
28 **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**




