

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Gerald Fayuant as Department of Planning and
Economic Development Executive Director)**

RESOLUTION NO. 16-315

1 **WHEREAS, Article VII, Section 2(e) of the Constitution of the Tohono O'odham Nation vests**
2 **the Nation's chairperson with the authority to appoint the Nation's treasurer,**
3 **and other officers and heads of all governmental departments with the approval**
4 **of the Tohono O'odham Legislative Council; and**

5 **WHEREAS, Chairman Edward Manuel has identified Gerald Fayuant as the appointee for**
6 **the Department of Planning and Economic Development Executive Director;**
7 **and**

8 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
9 **O'odham Legislative Council, the chairperson's "appointee to the position of**
10 **treasurer or other officers or heads of governmental departments shall not be**
11 **added to any Legislative Council session agenda for approval unless the**
12 **appropriate legislative committee interviews the appointee after receiving a**
13 **resume and written background investigation report" containing detailed**
14 **employment, education, credit, litigation, and other information necessary to**
15 **determine the appointee's qualifications and fitness; and**

16 **WHEREAS, the Legislative Council Commerce Committee has received and reviewed the**
17 **detailed written background investigation report required by the Legislative**
18 **Rules, interviewed the appointee, and recommends that the Legislative Council**
19 **approve the appointment.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **appointment of Gerald Fayuant as Department of Planning and Economic**
22 **Development Executive Director; provided that Gerald Fayuant shall serve until**
23 **replaced at the request of the Nation's chairperson.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
25 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 2,242.9 FOR; 778.5**
26 **AGAINST; [01] NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d) and Article VII, Section 2(e) of the Constitution of the Tohono O'odham**
28 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the**
29 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
30 **Section 16 of the Act of June 18, 1934 (48 Stat.984).**
