8		O'odham Legislative Council, the chairperson's "appointee to the position of
9		treasurer or other officers or heads of governmental departments shall not be
10		added to any Legislative Council session agenda for approval unless the
11		appropriate legislative committee interviews the appointee after receiving a
12		resume and written background investigation report" containing detailed
13		employment, education, credit, litigation, and other information necessary to
14		determine the appointee's qualifications and fitness; and
15	WHEREAS,	the Legislative Council Water Resources Committee has received and reviewed
16		the detailed written background investigation report required by the Legislative
17		Rules and interviewed the appointee, and recommends that the Legislative
18		Council approve the appointment.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		appointment of Selso Villegas as Department of Water Resources Executive
21		Director; provided that Selso Villegas shall serve until replaced at the request of
22		the Nation's chairperson.
