

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Revenue Projections of the Nation)

RESOLUTION NO. 16-320

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage**
2 **any funds within the exclusive control of the Tohono O'odham Nation"**
3 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, the Legislative Budget and Finance Committee and the Executive Office**
5 **reviewed the revenue projections for FY 2017; and**


6 **WHEREAS, the Nation's Treasurer has calculated that \$85,903,177.00 is needed to fund the**
7 **Nation's FY 2017 General Fund budgets for the Executive, Legislative and Judicial**
8 **Branches; and**

9 **WHEREAS, the Budget and Finance Committee and the Executive Office recommend the**
10 **adoption of the FY 2017 Revenue Projections, incorporated by this reference, in**
11 **the amount of \$85,903,177.00 to fund the FY2017 General Fund Budgets.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**
13 **approves the FY 2017 revenue projections in the amount of \$85,903,177.00 for**
14 **the purpose of funding the FY 2017 General Fund budgets of the Tohono**
15 **O'odham Nation.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH**
17 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 2,840.8 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and 180.6 [05] ABSENT, pursuant to the powers vested in the Council**
19 **by Article VI, Section 1(d) of the Constitution of the Tohono O'odham Nation, adopted by the**
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
22 **June 18, 1934 (48 Stat.984).**


