

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2017 Executive Branch Tribal Budgets and Appropriating the
amount of \$72,209,206.28 from the General Fund)**

RESOLUTION NO. 16-322

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, The Executive Branch has prepared and submitted for review and approval its**
8 **FY 2017 Tribal Budgets for the period beginning October 1, 2016 and ending on**
9 **September 30, 2017 which are incorporated in summary by this reference and**
10 **detailed in Schedule A, for a total amount of \$76,209,206.28 to be funded from**
11 **the General Fund; and**

12 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2017 Executive Branch**
13 **Tribal Budgets and recommend their approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2017 Executive Branch Tribal Budgets effective on October 1, 2016 and ending**
16 **on September 30, 2017 in the amount of \$76,209,206.28 which shall be funded by**
17 **the General Fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
19 **O'odham Nation chairperson or any designated official is authorized to**
20 **administer and expend the FY 2017 Executive Branch Tribal Budgets, provided**
21 **that any amendments or modifications shall be submitted for prior approval by**
22 **the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH**
24 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
29 **June 18, 1934 (48 Stat.984).**




