

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Christmas Bonus for Full-Time Employees and Officials of the Nation's Executive Branch, Judicial Branch, and the Legislative Branch)

RESOLUTION NO. 16-323

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**


7 **WHEREAS, the Tohono O'odham Nation fiscal year 2017 budgets provide for a Christmas**
8 **Bonus of \$500.00 for every full-time employee and official of the Nation's**
9 **Executive Branch, Judicial Branch, and the Legislative Branch hired by**
10 **December 9, 2016; and**

11 **WHEREAS, the Budget and Finance Committee recommends that the Legislative Council set**
12 **eligibility criteria for full-time Nation's employees and officials receiving a**
13 **Christmas bonus.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes a**
15 **\$500 Christmas bonus for full-time employees and elected and appointed**
16 **officials of the Nation's Executive Branch, Judicial Branch, and the Legislative**
17 **Branch hired before December 10, 2016; provided that the bonus shall be issued**
18 **on or before December 19, 2016.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH**
20 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 1,799.3 FOR;**
21 **1,222.1 AGAINST; [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the**
22 **Council by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation,**
23 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
24 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
25 **16 of the Act of June 18, 1934 (48 Stat.984).**
