(Authorizing Christmas Bonus for Full-Time Employees and Officials of the Nation's Executive Branch, Judicial Branch, and the Legislative Branch)

**RESOLUTION NO. 16-323** 

1	WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds
2		within the exclusive control of the Tohono O'odham Nation and to
3		appropriate these funds for the benefit of the nation and its members" provided
4		that "[a]ll expenditures of these funds shall be pursuant to appropriations or
5		budgets" authorized by resolution or ordinance (Constitution of the Tohono
6		O'odham Nation, Article VI, Section 1(d)(2)); and
7	WHEREAS,	the Tohono O'odham Nation fiscal year 2017 budgets provide for a Christmas
8	,	Bonus of \$500.00 for every full-time employee and official of the Nation's
9		Executive Branch, Judicial Branch, and the Legislative Branch hired by
10		December 9, 2016; and
11	WHEREAS,	the Budget and Finance Committee recommends that the Legislative Council set
12		eligibility criteria for full-time Nation's employees and officials receiving a
13		Christmas bonus.
14	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes a
15		\$500 Christmas bonus for full-time employees and elected and appointed
16		officials of the Nation's Executive Branch, Judicial Branch, and the Legislative
17		Branch hired before December 10, 2016; provided that the bonus shall be issued
18		on or before December 19, 2016.
