

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2017 Legislative Branch Budget)

RESOLUTION NO. 16-324

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to**
3 **appropriate these funds for the benefit of the nation and its members" provided**
4 **that "[a]ll expenditures of these funds shall be pursuant to appropriations or**
5 **budgets" authorized by resolution or ordinance (Constitution of the Tohono**
6 **O'odham Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its**
8 **FY 2017 Legislative Branch Budget, which is incorporated by this reference; and**


9 **WHEREAS, the Budget and Finance Committee of the Legislative Council has reviewed the**
10 **FY 2017 Legislative Branch Budget and recommends its approval and adoption.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
12 **and authorizes expenditures of the FY 2017 Legislative Branch Budget in the**
13 **amount of \$3,368,603.45, which shall be funded by the Nation's general fund,**
14 **beginning October 1, 2016 and ending September 30, 2017.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**
16 **O'odham Legislative Council chairperson or any designated official is**
17 **authorized to administer and expend the FY 2017 Legislative Branch Budget,**
18 **provided however, that any amendments or modifications shall be submitted**
19 **for prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH**
21 **day of JULY, 2016 at a meeting at which a quorum was present with a vote of 3,021.4 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
24 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
26 **June 18, 1934 (48 Stat.984).**
