8		FY 2017 Legislative Branch Budget, which is incorporated by this reference; and
9	WHEREAS,	the Budget and Finance Committee of the Legislative Council has reviewed the
10		FY 2017 Legislative Branch Budget and recommends its approval and adoption.
11	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
12		and authorizes expenditures of the FY 2017 Legislative Branch Budget in the
13		amount of \$3,368,603.45, which shall be funded by the Nation's general fund,
14		beginning October 1, 2016 and ending September 30, 2017.
15	BE IT FINAL	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
16		O'odham Legislative Council chairperson or any designated official is
17		authorized to administer and expend the FY 2017 Legislative Branch Budget,
